AUDIT SUMMARY

Results in brief

In the areas we audited, Agency operations complied with applicable requirements and provided adequate safeguarding of public resources. The Agency also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of TCOMM 9-1-1 from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Agency's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open public meetings
- General revenue/expenditures
- Key system controls
- Financial condition
- Procurement – purchases
- Payroll disbursements
- General disbursements

Thurston 9-1-1 Communications, doing business as TCOMM 9-1-1, is a county-wide enhanced 9-1-1 answering point and dispatch center for public safety, law enforcement, fire service and Medic One. The Agency was incorporated on January 1, 2011, formed through an inter-governmental agreement between 26 public safety agencies with the signatures of the jurisdictions they represent. The Agency operates under the laws of the state of Washington applicable to a Not-for-Profit Special Purpose Governmental Agency and is registered with the Internal Revenue Service as a 501(c)3.
