AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Agency operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the TCOMM911 from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Agency's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open public meeting minutes
- Financial condition and fiscal sustainability
- Procurement – purchase of telecommunications equipment
- Controls over accounts receivable
- Credit card disbursements

INFORMATION ABOUT THE AGENCY

Thurston 9-1-1 Communications, doing business as TCOMM 9-1-1, is a county-wide enhanced 9-1-1 answering point and dispatch center for public safety, law enforcement, fire service and Medic One. TCOMM 9-1-1 was incorporated on January 1, 2011, formed through an intergovernmental agreement between 26 public safety agencies with the signatures of the jurisdictions they represent.

The Agency operates under the laws of the state of Washington applicable to a Not-for-Profit Special Purpose Governmental Agency and is registered with the Internal Revenue Service as a 501(c)3. For 2015 and 2016, the Agency operated on annual budgeted expenditures of \$7,639,602 and \$8,068,190, respectively.
